Sellscreen Privacy Policy

Website Visitors

- 1. Like most website operators, Sellscreen collects non-personally identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Sellscreen's purpose in collecting non-personally identifying information is to better understand how Sellscreen's visitors use its website. From time to time, Sellscreen may release non-personally identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.
- 2. Sellscreen also collects potentially personally identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on our blog. Sellscreen only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally identifying information as described below, except that blog commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog where the comment was left.

3. Gathering of Personally Identifying Information

Certain visitors to Sellscreen's Website choose to interact with Sellscreen in ways that require Sellscreen to gather personally identifying information. The amount and type of information that Sellscreen gathers depends on the nature of the interaction. Those whom engage in transactions with Sellscreen are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Sellscreen collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Sellscreen. Sellscreen does not disclose personally identifying information other than as described below. And visitors can always refuse to supply personally identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

4. Aggregated Statistics

Sellscreen may collect statistics about the behavior of visitors to its website. Sellscreen may display this information publicly or provide it to others. However, Sellscreen does not disclose personally identifying information other than as described below.

5. Protection of Certain Personally Identifying Information

Sellscreen discloses potentially personally identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Sellscreen's behalf or to provide services available at Sellscreen's website, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors

and affiliated organizations may be located outside of your home country; by using Sellscreen's websites, you consent to the transfer of such information to them. Sellscreen will not rent or sell potentially personally identifying and personally identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Sellscreen discloses potentially personally identifying and personally identifying information only in response to a subpoena, court order or other governmental request, or when Sellscreen believes in good faith that disclosure is reasonably necessary to protect the property or rights of Sellscreen, third parties or the public at large. If you are a registered user of a Sellscreen website and have supplied your email address, Sellscreen may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Sellscreen and our products. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Sellscreen takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally identifying and personally identifying information.

6. Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Sellscreen uses cookies to help Sellscreen identify and track visitors, their usage of Sellscreen website, and their website access preferences. Sellscreen visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Sellscreen's websites, with the drawback that certain features of Sellscreen's websites may not function properly without the aid of cookies.

7. Business Transfers

If Sellscreen, or substantially all of its assets, were acquired, or in the unlikely event that Sellscreen goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of Sellscreen may continue to use your personal information as set forth in this policy.

8. Ads

Any ads appearing on our website may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by Sellscreen and does not cover the use of cookies by any advertisers.

9. Accessing and Correcting Your Information
